2011 Vendor Fees:

ALL vendors requiring electricity will be charged as follows, IN ADDITION TO THE NORMAL VENDOR FEE:  
\$15 per day for each 110v outlet used

\$30 per day for each outlet used exceeding 110v

THESE ELECTRICITY FEES MUST BE PAID TO THE HORSE SHOW DIRECTLY. A "day" is every day you are present on the grounds (including non-show days)

2. Vendor Fees: (check to reserve)

3. WE PREFER FOR ALL VENDORS TO PAY IN ADVANCE OF ARRIVAL. IF YOU DO SO, YOUR SPACE IS GUARANTEED. VENDORS WHO DO NOT PAY IN ADVANCE ARE EXPECTED TO PAY PROMPTLY BY SATURDAY SEPTEMBER 24 IN THE HORSE SHOW OFFICE. WE ARE NOT RESPONSIBLE FOR COMING TO YOUR LOCATION TO COLLECT YOUR FEE – WE EXPECT YOU TO DO THIS. VENDORS WHO FAIL TO PAY IN A TIMELY MANNER WILL NOT BE ALLOWED TO PARTICIPATE IN FUTURE EVENTS.

4. ALL VENDORS MUST HAVE A CERTIFICATE OF LIABILITY INSURANCE AVAILABLE FOR INSPECTION AT ALL TIMES WHILE ON THE HORSE PARK GROUNDS.

5. KENTUCKY STATE SALES TAX APPLIES TO ALL SALES MADE IN KENTUCKY. STATE REVENUE AGENTS FREQUENTLY APPEAR AT KHP EVENTS TO ENCOURAGE COMPLIANCE.
